D.McCullough seconded the motion



Thank you for the opportunity to provide a Current Market Analysis that will help you in the sale of tax parcel ID 0215175404220 owned by Wishram School District. This lot is approximately .09 of an acre in size.

Currently there are no lots in Wishram, under 1 acre in size, listed for sale on the Regional Multiple Listing System.

In the last 36 months, there were two sales involving lots under one acre in size. On 12/21/2015, I was involved in a sale that involved three lots that were each .12 of an acre in size. (LOTS 6-9 BLK G BUNN & MCGRATH WISHRAM SWNE; 17-2-15) All three lots sold for a total of \$12,000. This is an average of \$4,000 each.

On 10/31/2016, those same three lots were sold for \$20,700. This is an average of \$6,900 each.

In my professional opinion, according to publically available data, the school district lot should be worth \$4000 to \$6900. These numbers could vary because of location, specific needs of the buyer, as well as the limited supply of lots available in Wishram.
