Superintendent Report

1. As of today, we had 3429 missing assignments turned in for the 2020-2021 school year. This represents a huge district wide push to get all of our students to get their work caught up. Within the last two weeks, our total number of missing assignments has decreased from over 380 missing assignments to 32. Our staff has done a wonderful job working with our students, and encouraging them to take this opportunity to pass all of their classes despite to obstacles presented by the pandemic. This will dramatically reduce the amount of students who are credit deficient moving forward, and represents a huge win for Wishram School District #94 as a whole.

Director of Operations Report

North Wall:

Due to many change orders, we only have about \$108,000 left in the grant for the North Wall. However, Tapani is telling us that there should be no more change orders. This is very little money left for a project of this size.

Since we met last, the construction has moved right along. All the concrete has been poured, however they had to tear out one of the pads at the CTE building because it was not level with the other pad. All interior walls have

been built and most have new drywall on them. Some of the painting has even started. The CTE Building and weight room now have HVAC in there.

- 2. put the kitchen back together
- 3. rebuild the weight room

- 5. place all the dirt back while compacting it in
- 6. install fencing
- 7. install new irrigation system
- 8. plant new field

PUD: We put in the new 1" irrigation meter on Tuesday. It works great. They replaced our 2" meter for the main school with a 1.5" meter yesterday. This will save us money.

Athletics: Basketball is going great, despite wearing the masks.

Lead Teacher Report

ELEMENTARY: Reported by K.Hilton:

- Elementary Awards will be held June 11th at 11:00 on the elementary playground. Families will be invited to attend and bring their own chairs and blankets to sit on the grass to sit within their own households to be within covid guidelines. Masks will be required. We will also have students leave with families after the ceremony, with lunch being offered.
- Elementary will be combining with some Secondary students to have a field day on the last day of school June 16. This is still under the planning phase but will include many different events for students to participate in and take about 2 hours of rotating in small groups and follow COVID restrictions.
- All k-12 students are completing their final reading and math i-Ready diagnostic tests. They are going very well and showing incredible growth with the students being in the building with in-person instruction compared to the first round that was during remote learning.
- REACH has just learned that the program has been fully funded for another year!
- REACH has started to plan summer school activities and visitors. The first day of summer school is June 21 and the last day will be July 14. This is a 4 week program for students that were signed up during the school year.

SECONDARY: Brent Cameron reported additional details about the awards ceremony and the graduation practice which will take place as well. Reported how many staff and students have been helping to get all students off the list. In the Social Studies class, they are studying the civil war. Science is studying genetics in biology and learned about the recent lunar eclipse in Earth Science class.
